

The Submissive Crowd

"All revolutions have failed? Perhaps. But rebellion for good cause is self-justifying – a good in itself. Rebellion transforms slaves into human beings, if only for an hour."

Edward Abbey

You can be the most pleasant, easy-going, kind-hearted person, but it really doesn't matter to the "normal' members of Society: "the followers", those who are scared and hostile towards anybody they see as different from what they perceive to be acceptable or decent. Wearing differently cut clothes or having a weird haircut is enough to risk the ire of the "good people" it seems, without even mentioning possessing different manners or perspectives counter to the mainstream. If you have ideas that challenge the status quo, and you're determined to commit them to experience, be ready for their anger and grudges. With narrow minds and low horizons, the submissive crowd is the eyes, ears and mouths of repression; Grovelling conformists, who, -when they are not looking out for "terrorists" and "criminals" - are busy sniffing and snitching out any of those who don't go through life like one of a herd of sheep.

Sheep who scrabble for money, lie, cheat and back-stab to get what they want, dominate other people when they can, and beg for protection and mercy from the authorities. "Neighbours", "communities", and "citizens"; mostly just more words for those who fill the streets with their xenophobia, nationalism and hypocrisy. Those who respect social mediocrity and fawn to power deserve my contempt. Their world must go.

About the case of the arrested anarchists in Nea Filadelfeia (Northern Athens - Greece)

Information about the arrest of five anarchists on Tuesday noon, April 30th, the criminal proceedings against them, and the hunger/thirst strike of comrade Dimitris Hadjivasiliadis.

On Tuesday, April 30th, at around 4pm, anarchists **Yannis Naxakis** and **Grigoris Sarafoudis** were arrested on Dekeleias avenue in the district of Nea Filadelfeia, as they were coming out of a cafeteria.

At the same time, a large police force stormed the café and caught the anarchist fugitives **Argyris Ntalios**—who tried to break out of the kettle— and **Fivos Harisis-Poulos**. Both comrades had arrest warrants pending against them since mid-February 2013 (after the double robbery in Velventos—Kozani and the incarceration of anarchists Andreas-Dimitris Bourzoukos, Dimitris Politis, Nikos Romanos and Yannis Michailidis).

Anarchist **Dimitris Hadjivasiliadis** was also arrested inside the same cafeteria in Nea Filadelfeia.

All five were transferred to the anti-terrorism service on the 12th floor of the Athens police headquarters. The two comrades that were caught out on the street, as well as the two that were wanted by the authorities encountered the violence of statist dogs in the anti-terrorist office. The fifth comrade was forced to stand for twelve hours hand-cuffed tightly behind his back —what officially is considered torture— and when he was taken into a cell (the white cells of the 12th floor), he remained handcuffed for several hours.

The same evening, the Greek security force put out a report that accused all of them of resisting arrest and giving false testimony – because the five anarchists refused to give fingerprints, profiles or DNA samples, which were ultimately taken by force. In addition, Naxakis, Sarafoudis and Hadjivasiliadis were charged with harbouring fugitives.

On Wednesday noon, May 1st, the arrestees were all transferred to Evelpidon courts, where the media crows were lurking, and were met with the comrades' hostility. The comrades stood before prosecutor and interrogator without any formal indictment and (for some) without being allowed to meet with a defense lawyer in advance that would also be present in the hearing, what perhaps occurred for the first time in the history of similar cases. The judges applied their usual tactic to postpone the preliminary hearing for two days regardless of the arrestees' wishes. Ntalios, Harisis, Naxakis and Sarafoudis refused to make any statement. On the other hand, Hadjivasiliadis demanded that he be heard immediately with the presence of a defense lawyer. His demand was dismissed, so the comrade stated that he has denied food and water already from the moment of his arrest, and he goes on hunger/thirst strike for as long as he is locked up in the white cells of the antiterrorism torturers. Lastly, he held the judges responsible for his prolonged custody on the 12th floor of the Athens police headquarters, where the cops were attempting only to 'manufacture' an accusatory brief against the three anarchists for whom no warrants were outstanding in order to ask for their pretrial incarceration.

On Wednesday evening, preventive detention warrants were executed against the two exfugitives, and Fivos Harisis and Argyris Ntalios were transferred to Koridallos prison.

On Thursday, May 2nd, Ntalios, Harisis, Naxakis and Sarafoudis were charged in past robbery cases on the basis of 'findings' from DNA samples that were forcibly taken by them. Additionally, an appellate judge who handles such cases issued preventive detention warrants against Yannis Naxakis and Grigoris Sarafoudis. An indictment was presented to all five arrested in Nea Filadelfeia, including the accusation of 'membership into a criminal organization with a view to committing robbery, in accordance with the Greek antiterrorist law, without exhibiting any direct evidence of premeditation or even intent, other than some orange juices served on the cafeteria table...

Meanwhile, on Thursday, the cops staged a psychological war on Hadjivasiliadis to make him stop the strike. They brought water bottles inside the cell, repeatedly 'offered' him food and water, and threatened him that he would stay there for many more days. Hadjivasiliadis and his lawyer insisted on his right to medical examination. A doctor came in at night, and assured him that there was no immediate danger to him at this stage but his condition could deteriorate any moment. The doctor also told the screws to leave the transom window of the cell's door open, to help the striker breathe more efficiently.

On Friday morning, May 3rd, the five anarchists were brought to Evelpidon courts once again, where only a few comrades and relatives were gathered in solidarity. Four of the accused insisted upon their refusal to make any statement. Then Ntalios and Harisis read a text in solidarity to striker Hadjivasiliadis, declaring that he is being held without any substantial evidence whatsoever against him. The judges had no basis to press criminal organization charges against the arrestees and set bail conditions instead for all five of them.

Nevertheless, Dimitris Hadjivasiliadis was the only one to be released, and thus stopped his three-day hunger and thirst strike.

Argyris Ntalios and Fivos Harisis were taken back to Koridallos. The Solidarity Fund for imprisoned and persecuted fighters (Greece) released their prison address:

Dikastiki Filaki Koridallou, A Pteryga, 18110 Koridallos, Athens, Greece In the meantime, Yannis Naxakis and Grigoris Sarafoudis were still held as suspects in bank robbery case, awaiting further proceeding in the city of Larissa. According to mainstream media, these two anarchists were brought before an interrogator on Saturday, May 4th. They are said to be remanded and moved to Koridallos prison.



Athens, Greece: Conspiracy of Cells of Fire -Trial updates

CCF, 3rd trial updates Session 44.

This session began with tension since in the previous days the detainment of a comrade-member of the CCF and another accused comrade was extended for 6 more months. With this decision of the council of judges, the comrademember of the Conspiracy will complete 36 months held on remand when the limit of detainment without being sentenced is 18 months.

In the tension caused, participated many comrades of the CCF who turned towards the judges, telling them to abandon their democratic façade and the rhetoric of politeness, since they are servants of the system and eternal enemies of them. Just before that the judges claimed to not know anything and that they cannot comment on their colleagues decision. Against this recital of humanity and hypocrisy, a comrade of the CCF said:

"We do no expect anything from you besides long term sentences which you will impose on us. But do not pretend to be sensitive because you are not convincing anyone. There is a war between us and we will not call a truce even for a moment..."

While the other comrade of the CCF whose detainment was extended for 6 more months

totalling 36 months, "reminded" that a year ago when he was in the hospital on hunger strike, again then the special interrogator "renewed" his detainment for 12 more months a day before he was going to be released. The trial was interrupted because of the tension and continued with the testimonies of witnesses for the case of the parcel bombs by the CCF.

Employees of courier companies and an employee from the Swiss embassy testified. The latter mentioned that when the parcel initially arrived she thought it was "suspicious", but finally the consul of the embassy received it and opened it in the outside area of the building.

Then she, from a distance, realized that there was a smell of sulphur in the air and as the consul told her, when he opened the parcel there was an ignition and a large flame popped out of the parcel. In their statements the comrades of the Conspiracy mentioned to the reasons of their choice of targeting the Swiss embassy, referring to the imprisoned comrade Marco Camenish (who has been in prison for 20 years) as well as the three anarchists (Sylvia, Billy, Costa) who were arrested back then in Switzerland charged with trying to blow up the offices of IBM [specifically a nano-technology lab under construction]. The trial was adjourned till Tuesday April 30th.

Session 45

This session included prosecution witnesses for the parcel bomb case. Amongst them appeared an employee of a courier company who had recognized some of the "accused" as senders of the parcels. Finally, during her testimony she implied that a large part of her testimony as well as the recognitions, are created by the anti-terrorist force.

In a statement of his, a comrade of the Conspiracy stressed that "The CCF does not care about the penal consequences and the decision of the court. But it is important to reveal the methods of the antiterrorist force as a legacy of knowledge and as a protection mound for the new comrades."

Also, he added, "Lets not forget that in this trial there have been accused also individuals who have none neither could have had any relation with the Conspiracy."

To a question by the prosecutor if the CCF cares about the acquittal of the

rest of the "accused", the comrade was clear. "the acquittal of the rest of the comrades, who are indeed innocent, is a job for their lawyers. We are not lawyers. But we want and we will- to preserve history and the honour of the organization."

The rest of the witnesses were couriers who unwillingly had carried parcel bombs.

Session 43.

This session was postponed because of an illness of one of the judges.

Session 42.

In this session, amongst the other prosecution witnesses, appeared also a cop of the antiterrorist force.

This specific cop stated that he serves in the "department against the anarchists", causing tension in the court room. In his testimony he added that he carried on him photos of some of those wanted for the CCF (to help him in locating them) and stressed that he took orders directly from the "headquarters" of the antiterrorist force.

During the examination of the rest of the witnesses, at some point the prosecutor stated that it seems from the attitude of the comrades of the Conspiracy, shows that they are indifferent about the charges, since as they themselves stress they take the responsibility for the actions of the CCF and speak of the continuation and intensification of the anarchist urban guerilla.

Session 41,

This session began with the testimony of an appointed advocate. Let us note here that many comrades of the CCF because of their refusal of any legal representation they have appointed advocates, since according to the legislation if the "accused" refuse to have an advocate, then the court itself appoints one for them. The appointed advocate therefore testified that a few days ago there was a burglary in his work office and the unknown burglars took from him documents concerning the case of the CCF without stealing anything else of value from him.

There was tension in the court room and eventually the appointed advocates left and the trial was adjourned until the next session.

Session 40.

The whole session was about examining witnesses who either were owners of houses which the CCF rented out as safe-houses, or their identity info was found on fake identity cards. During the recognition-snitching of the comrades of the Conspiracy by the prosecution witnesses, it was impressive that a comrade of the CCF was recognised as a tenant, with a fake id card, of a safehouse, at the time that he was in prison. It is characteristic as it was proven by the juridical procedure, that almost all the safe-houses of the Conspiracy which have been discovered so

far, were not declared to the tax office so that it is difficult to track them and cross check the fake information. The witnesses that followed were called to recognize the comrades if they were the same people who set up police blocks in order to copy their identity card info.

It is reminded that the comrades of the CCF would disguise themselves and pretend to be cops carrying out fake stop and checks in order to copy real identity information and use them on fake id cards in order for them to be convincing and of existing people.

CCF, 4th trial starts Session 1.

5th April 2013: One more trial for the actions of the CCF began at Koridallos prisons.

Besides the members of the Conspiracy accused in the same case are also Dimitris Politis, Giannis Mihailidis, Giorgos Karagiannidis, Alexandros Mitrousias, Kostas Sakkas and Stella Antoniou (who are also accused in the third trial which is taking place as well) and Kostandina Karakatsani and Panagiotis Masouras.

Theofilos Mavropoulos read a

common statement of the now ten members of the CCF, after which all members of the organization left the room.

"As I have stated in a previous court and in older public texts, I have been next to the comrades of the CCF as a solidarian anarchist, without however being a member of the Conspiracy. From the first moment of my arrest after the shoot out with the cops in Pefki, the comrades of the Conspiracy stood next to me like brothers. Inside prison we shared common worries, tensions and forged our steel passion for liberation through our common escape attempt in December 2011. Today for me the CCF is an inseparable piece of my thought, my desires and my personal mutiny for anarchy. This is why as of today, here in

This is why as of today, here in your court, I state that I join the CCF and share together with the imprisoned and non arrested members the endless course to the anarchist insurrection. Partici-

pating now in the Conspiracy, I will read a collective statement for this trial. All of us, the members of the CCF, want to clarify some things.

In this trial, besides us who have taken the responsibility for our participation and support of the Conspiracy, all other accused do not have, neither have any relation with the charges attributed to

They never were, neither could ever be members of the Conspiracy. An ocean of disagreements, perceptions and choices divides us...

The CCF and FAI is an international network of anarchists of praxis who stand against the enemy with the certainty of those who play it all or nothing and refuse the proof of innocence and legal mitigations.

The Conspiracy and the Informal Anarchist Federation through their hundreds of attacks express the black anarchy which sets fire to the silence of the many and cowardice of the reformists.

All the charges in your indictments are a

All the charges in your indictments are a piece of the anarchist history and the armed course of the Conspiracy through the social desert of mass subjugation. It is our compass in the unmapped unknown of the anarchist insurrection. It is the unique moment where theory meets practice.

It is there where the law dies and anarchy is born.

It is there where the sounds of the explosions and the gun shots break the calmness of the crowd.

These moments are our moments. These history is our history.

A history which cannot be put on trial, neither finishes inside the court room. We are the gasoline, the gun powder, the detonator, the bullet, the gun. The only thing you will get from us is war. The Conspiracy is, was, itself. This is our Anarchy".

G.Mihailidis read a common statement of his and D.Politis and then left the procedure.

"Give us a copy", asked the chairman, "this statement is not for you", answered D.Politis, while the cops were cuffing them.

The statement:

"We state that: We refuse to participate in the procedure of the court, not only because it is a mean of the state to demean and bend the anarchist struggle, not only because its function aims at the respite of anarchist action, but mainly because we do not recognize any institutional representative of the bour-

geois democracy to judge people. As anarchist revolutionaries we stand hostile against the bourgeios justice which sends people to the rot of imprisonment in order to defend the criminal lawful order of capitalism. Also, we support the anarchist revolutionary war in every one of its forms. We are part of the violent and guerilla action and will defend it as an inseparable part of the struggle."



Letter from anarchist prisoner Andreas-Dimitris Bourzoukos

A.D. Bourzoukos is one of the 4 anarchist comrades arrested on 1st February 2013 following the double robbery carried out in Velventòs

'It wasn't quite dawn yet But I have never accepted defeat'

25 minutes past midday. The last time I had a look at the time. Behind us a patrol car and in the van my two comrades, the 'hostage' and I. Only a few minutes earlier our emotions were completely different. For an instant, everything seemed to be perfectly all right, until they arrested our comrade in the 'ambulance'. All of a sudden we lost heart but in spite of this we remained as much lucid as we could, and in this way we managed to ensure our comrades' escape.

Let's go back to the picture of the beginning: the three of us along with the 'hostage' in the van and an 'accidental' encounter (actually it was not at all accidental because the alarm had been raised in all the surrounding villages) with a patrol car. In the last minutes of our freedom the countdown had already started. What we said to each other in the van is not relevant to our story, what is relevant is our final decision. We wouldn't have fired and put the doctor's life in danger. But it was our only choice at that moment. However the only weapon we had in those conditions was our passion for freedom. And we used it as best as we could. After a chase in the streets of Veria, just like in a film, we got finally trapped by a patrol passing there by chance, in a dead end road. It is pointless to tell the rest of this story once again.

The only thing I'd like to clarify is the part concerning torture, as this was quite a big thing. I know that in society the image of someone who got beaten up can generate fear, compassion or doubts. But this is not the case with us comrades. I also want to say that the State intentionally allowed our photos be made public, and they did so with the intent to terrorize those who might think to do what we did. Perhaps it was a 'mistake' due to hurry and the fact that any operation of the Anti-terrorism Squad is done almost automatically. Be that as it is, I don't want to concentrate on this now. Instead, I'd like to shortly talk about the thoughts that crossed my mind during the time we were beaten up.

I never felt like a victim and of course I don't want that others consider me as such. During those four hours of continuous beating one of the things I was thinking about was the possible scenarios on the 'end' the cowardly and bully pigs had in mind. Neither fear nor pain, just anger. In spite of how much truth can hurt, you just take someone by the hair and put them on their knees. While the beating was going on without stopping I recalled all the years when I had chosen to clash with this rotten system. All my choices and thoughts became flesh and bones. Perhaps one single minute with my hands tied would have been enough. Perhaps the torture was just a proof confirming how the system is rotten.

But let's talk about money now, the money that flows abundantly (including during these times of crisis) in banks, public offices and all kinds of capital investment (like Cosco). This is the blood of capitalism.

My refusal to become yet another well-oiled clog of the system is one of the many reasons why I decided to carry out a bank robbery (personally I call it 'expropriation'). I mean I've never wanted to be another 'pedestrian' on this earth, one who has a 'normal' job and a 'normal' life. I didn't take much to understand that work aims at exploiting the human being for the sake of Capital, of the concentration of capital in the hands of few, which doesn't take

much to show its side effects. At that point I asked myself some questions: were fraud and corruption leading the system to crisis isolated cases or is the crisis itself a pre-arranged plan that serves to achieve yet more profits? Was the 'crash' of the bank system due to lending or was it a capitalist trick for more concentration of capital, for an even bigger capitalization?

Surely we are facing an unprecedented crisis in capitalist reality and surely the crisis was preceded by the 'crash' of the bank system. But we are talking about two sides of the same counterfeit coin. Capitalism couldn't exist without the bank system nor would exist one of the most important means of capital concentration. As the State was called in to fill up bank safes when the crash of the bank system was imminent, so banks were called in to strengthen investments and pave the way to a new capitalization of the banks immediately after the collapse of the State machinery. A vicious circle that serves to spare death to moribund capitalism.

Looking at the brief history of Greece in the European Union and at its economic collapse I can only interpret it as something that was planned in advance, both Greece's collapse and that of other European countries hit by the crisis. As Greece joined the euro zone with a 'creative logistics' (as Greek logistics has been called), prime minister Simitis talked about a wonderful era and presented Greece as a strong country, in constant development, just like any other EU state. And at that time the middle class hoped in the advent of the capitalist heaven. But this ended with the 2008 crisis, the 'mark' of the capitalist system, and the beginning of collapse. What followed was once again 'creative logistics', this time introduced by Giorgios Papandreu so as Greece could benefit of financial support mechanisms (IMF-ECB). And then we came where we are today, to the total selling off of people's lives and the elimination of human dignity. Of course this goes hand in hand with low-cost investments and opportunities for the plunder of nature, as they are doing today in several places.

Lived experiences and the unbearable pressure imposed on society are sufficient to demonstrate the dirty face of capitalism in all its clarity. I recognize my action as expropriation. To me the real thieves are those who administer bank executive bodies and the state apparatus. An obvious assistant of the crisis of the system is repression, be it generalized or aimed at an objective, and repression is

meant to terrorize and debilitate the whole society. Its main target is the wide anarchist-subversive spectre, which often acts as detonator and catalyst for insurrection, tensions and the anger that is increasingly spreading in different social sectors.

The paradox of the repressive politics of the State can be seen in the way it also strikes other social sectors that resist as it describes them as 'illegal and terrorist people who only want destruction'. An example of this is the spasmodic reaction of the State after the events of Skouries. The massive fire that totally destroyed the equipment of the gold mines was quickly labelled as 'terrorist attack'. It is a fact I welcome and I'm on the side of those who realized it. The only possible dialogue with a multinational that wants to destroy and plunder nature for its profits' sake is pure and hard attack. I acknowledge the courage of the people who opted for direct action and took their lives in their hands. They caused fatal injury to both the 'El Dorado' enterprise and the State. This is also the reason why on the following day the entire village of Skouries was literally inundated with forces of order, which promptly raided all the houses of the village. This method reminds of civil war and shows the totalitarianism of the State, which turned the village into a war zone. Of course they also talked of the 'involvement of terrorist anarchists' in this attack. Since the beginning the media hastened to locate the 'terrorists who gave instructions for the attack'. Media tactics are well-known: denounce, terrorize and vilify always following the guidelines of the messenger in charge, the Security of The State, the Anti-terrorism Squad or the government itself. Authentic 'workers' of oppression and submission are digging graves - deep enough to allow everyone in - so that the repressive arm can continue its work and the judiciary mafia can bury everything when resistance occurs.

In this way the delirium of the media (Goebbels-style propaganda) also set off immediately after our arrest. Perfect stuff for the news bulletins of terror and the screenwriters of the anti-terrorism fiction. I can't help recognizing a clear political line adopted by the media when with pomposity and sensationalism they talked about our 'certain participation in other actions besides the robbery'. Using a tactic similar to that employed in Italy in the mid-nineties to strike the anarchists (ORAI case), the Greek state is trying to repress all forms of resistance.

It was easy to imagine what was to happen in the days following my arrest. Some special prosecutor in charge of terrorism-related cases (can he be named Mokkas?) would summon me on the basis of empty evidence, apart form the conjectures of the Antiterrorism, and point at me as a member of some organization. Confirmation of this didn't take long to come.

I was summoned by the special investigation judge (in fact he's called Mokkas), who included me in the revolutionary organization Conspiracy of Cells of Fire. Of course I recognize the actions of the CCF and its members as revolutionary, but this doesn't prevent me from saying that I've got nothing to do with this organization. I've never been a member of it because of essential differences in both projectuality and the general perception of society. By making me a member of the CCF the State can easily increase my sentence and consequently the years I should spent in prison. But I think this is just putting all in the same bag, a flagrant grouping that automatically suppresses any political attitude of a fighter.

'The price of self-determination is never low, and in same cases it is incredibly expensive.'

Certainly the trajectory to revolution and anarchy cannot be covered with rose petals, but it is not the only trajectory either, no matter what the current situation is like. Our means are well-known and need constant development, and the range of choices we have in our armoury is wide enough. I think that any revolutionary has to have the necessary acuteness and lucidity to choose the most adequate 'weapons' according to the conditions. The road to resistance presents many aspects and we need a multiform struggle. It can be a poster calling for a strike, the occupation of some state-owned building, arson on a bank, an explosive attack on some structure of the State, expropriation of the money belonging to the State: the goal is still the same, i.e. on the one hand to strike the structures and functions of capitalism, on the other hand to spread the means, practices and conceptions of struggle for anarchy, for freedom.

I'm in a society very much varied and I always struggle for myself, my comrades, the definitive destruction of the system and the total collapse of the existent. This does not mean that I will stop criticizing those who deserve my critique because they are responsible for maintaining and reproducing a rotten and oppressing system with their tolerance and indifference.

'This revolution must be violent, even if violence is not right in itself. It would be absurd to hope that the privileged ones recognize the suffering and injustice caused by their privileges and that they decide to voluntarily renounce them.' Violence emerges from inside us and it is the only worthwhile response to the decay and misery generated by the system. The radicalization of society is obvious nowadays. The historically important question is: where is this polarisation heading to? A tangible example of this tension can be seen in the growing percentage of votes gained by Golden Dawn [Neo-Nazi political party] during the elections, and the recurrent episodes of racist attacks in the centre of Athens. Clearly this is a superficial 'extreme' position because it lacks conscience. Presenting itself as an alleged 'anti-system party' Golden Dawn has managed to recuperate most of the anger of some social sectors.

Needless to say, I'm not a supporter of the 'theory of the extremes', and I don't consider Golden Dawn as anti-system. It is even too clear to me that they are indeed part of the system and also a weapon of the system. This is the reason why Golden Dawn shouldn't attract less attention than it deserves.

We will organize for a multiform and lasting struggle to destroy work and its foundation of oppressive relations, and will do this through conscious expropriation of capitalist wealth with the aim of strengthening and supporting the struggle. We will continue on the road of direct action and total attack on the capitalist system. By constantly communicating and stirring up the anarchistsubversive environment as well as wider social sectors we can spread anarchist relations and self-management of our lives. By being constantly present in the streets and in wild street struggles we form our conscience and fighting soul, and violence spreads in the struggle. No: molotov bottles and barricades are not steps necessary to 'climb higher' and eventually dedicate oneself to gas bottles, bombs and armed struggle. Instead, they constitute an inseparable part of the struggle itself. One completes the other. Street struggle is as much necessary as is night sabotage carried out with all means against the machinery of the State. Armed struggle is one of the expressions of the fight, an indispensable expression that has to support the wider struggles of the movement and be supported by the latter. Any sabotage separated from the struggles of the movement and wider claims risks to pass through history in low profile, as if it was an unimportant event, and finally be erased.

Let's leave an indelible 'imprint' in history. The moment has come, let's make revolution possible and destroy plutocracy, for anarchy.

Manolada: Workers demand pay, Golden Dawn open fire (Greece)

200 workers (almost all of them from Bangladesh) went to the offices of their company in the region of Manolada (Peloponnese) to ask for six months of back wages. They were blocked by armed security staff, paid by the boss to defend his propriety and himself. Faced with a crowd insistently asking for what was theirs, the security reacted by shooting and wounding at least 34 people. It seems that Golden Dawn is implied in this story and the government is helping them to cover up the facts. Thousands of migrants are enslaved and often blackmailed because they don't have documents and risk deportation. An international boycott of the products, especially strawberries, coming from this bloody region has been launched with the cry of Boycott Manolada's Strawberries!

Gabriel Pombo da Silva transferred back to Villena Prison (Spain)

Remember that Gabriel was already in Villena and was transferred to Valdemoro to bring him to the National Hearing to give testimony in relation to the events in Italy (Operation Ardire). After Gabriel's refusal to give any statement, he was again transferred to Villena, again to keep him distant from his environment of family and friends. His address is:

Mayday build up for anti-G8 (UK)

Anti-capitalists have been gearing up for the protests against the G8 Summit with Mayday actions across the country. The focus was on Primark and other businesses profiting from the global slave labour system which led to the death of 700 people in Bangladesh. There were angry protests in central London, Hackney, Lewisham, Birmingham, Brighton and Bristol, with the clear message going out that the disaster was not an accident but the inevitable consequence of the callous capitalist system.

The anti-G8 activities will begin on the weekend of 8-9 June, with workshops and skillshares in preparation for the #J11 Carnival Against Capitalism on 11/6. There will be an anti-militarist demo on 12/6 and a No Borders No Prisons! day on 13/6.

Accused anarchist, Henry Zegarrundo, given house arrest (Bolivia)

After nearly a year in prison since the arrests, with over a dozen audiences suspended, Henry has finally been granted house arrest pending trial!

"With dignity as an ally, friend, and companion, and without bending before power, despite an environment overloaded with police collaboration, our comrade has honorably gotten out to be able to be with his own while awaiting resolution of the case."

The day of international solidarity for May 29 is still on: the accusations have not been withdrawn, one anarchist is still locked up as part of the case, people are still on the run, and the highway is still being built. Solidarity is a weapon!

RadioAzone: Wires of the telephone line and ADSL found cut (Italy)

From RadioAzione:

As I was updating the blog of RadioAzione vesterday afternoon, I found that the internet connection was no longer there. Similarly the telephone line was not working. Nothing strange, apparently, as technology is subjected to this kind of faults (besides many others, or rather it is technology itself the main fault). I promptly called the responsible for the ADSL and telephone contract and they said that everything was all right to them. After repeating that it was not all right, they sent an engineer this morning. He checked the cabin in the street (which contains the telephone connections of all the inhabitants of the area) and found it out that a wire had been cut... not disconnected but cut...

The door of the cabin had not been forced...

Among hundreds of users, why did they cut the wire of my connection? If someone had meant to damage the cabin they wouldn't have cut just one wire but all of them or most of them; and they would have forced the door of the cabin instead of opening it with a key.

I don't think it was an accident or something that happened by chance, considering the air you breathe in the city in this period. Meantime we have found back the 'Arianne's thread', and the written and live radio counterinformation is continuing. We hope we'll be able to celebrate as we did in the last year thanks to Pier Luigi Vigna (former anti-mafia prosecutor) and Antonio Manganelli* (national chief police, former chief police of Naples, or rather former chief of those who quite likely cut the wire of RadioAzione)... reconfirming that it will be our laughter that will bury you!

Update about anarchist prisoners Nicola and Alfredo (Italy)

24th April 2013 – As preliminary investigations came to an end on March 11 2013, Nicola and Alfredo will go on trial for 280bis (attack with purposes of terrorism), a proceeding also linked to the wounding of Ansaldo Nucleare manager Roberto Adinolfi, whose case (270bis - Subversive association) remains open for the two comrades plus another one.

No date has been fixed for the preliminary hearing for 280bis, as the prosecution has not yet

submitted the transcripts of the missing environment bugging. After two delays requested by the court, these transcripts should be ready by June 5 (it seems that the experts can't understand or transcribe Neapolitan dialect, which had sounded so clear to the judges from Genoa when it was used to corroborate the charges, according to the arrogant methods always employed to interpret environment bugging.)

As concerns the results of the examinations carried out by the RIS [a special technical investigations unit of the state] to compare the traces of gunpowder found on the helmets seized in Nicola's house and the weapons lawfully owned by his father found in the same house, they should be available in May.

As pointed out in previous updates, after a failed attempt at linking the traces of gunpowder to the bullets used in the wounding of Adinolfi, the prosecutors of Genoa tried it again, this time for the sake of 270bis, and clumsily envisaged an imaginary 'shooting training' undergone by the investigated comrades, of course without specifying where and when it took place (not to mention the fact that the helmets were seized during raids without the cops adopting any 'scientific' criteria, as they touched the 'evidence' with their dirty hands, carried it in their cars and to places where the defenders of disorder normally play with gunpowder.)

A new investigation of the ROS [special operations unit] was also put on record. This concerns farther examinations on the printers seized during the raids in the investigated comrades' houses, with the aim of comparing them with the leaflets of the claim of the attack on Adinolfi: this time the experts are compelled to admit that the leaflets are not compatible with either the ink or printing defaults of the printers, thus contradicting an earlier forensic examination which referred to a generic printing default very common to a great numbers of printer brands available on the market.

Comparative examination between DNA traces found on the handles of the scooters allegedly used during the attack and the DNA of 5 people investigated and searched in September, was also put on record by the RIS of Parma. As this comparison produced negative result, there came the nth attempt at investigating Alfredo for a double explosive attack on... the RIS of Parma that took place back in 2005 and was claimed by FAI/ Cooperativa artigiana fuoco e affini. It must be said that the mixed traces of DNA found on the wrapping of the device

outside the headquarters of the 'scientists' in 2005 were not reliable as evidence, as the cops themselves admitted adding that they had also touched the wrapping before carrying out examination. Nonetheless public prosecutor Federico Manotti has ordered Alfredo be questioned on the matter on May 7 in the prison of Ferrara... perhaps the prosecutor wants to ask him for suggestions on how to accuse him and for what charges.

In this case too the judge from Genoa is wielding article 280bis, even if it is clear that this investigation attempt is the result of random fishing out from a 270bis file concerning a number of investigated people (25 to 30, according to press releases), which refers to many attacks claimed by various groups of the Informal Anarchist Federation from 2003 onwards between Liguria, Tuscany, Emilia Romagna and Lombardy. The media also said that the prosecution of Genoa 'snatched' the investigation on the attacks on the RIS and Cofferati from their colleagues from Bologna.

Beyond career rivalries and jealousies between prosecutors and beyond the historical conflict between ROS and DIGOS [political police], the absolute incongruity and contradictions displayed in the use of forensic examinations is remarkable. This kind of examinations are totally unreliable, to say the least; they are good to create media/accusatory suggestions rather than prove something, as the script of the judges and cops' s dirty job always reads.

Nothing new under the sun: these are the usual wretched cogs of a world that must be destroyed.

Briefing on control systems (A text from Italy)

From a first reading of the court papers more detailed technical points emerge besides the traditional control methods such as shadowing, visual control, video monitoring of cameras placed outside houses and workplaces, use of bugs and satellite signals in cars, phone tapping, internet monitoring, etc. The new points are three, as already said a few months ago: the request for authorization of installing cameras inside houses (authorization that the investigating judge refused to grant, allowing only audio monitoring), the use of laptop cameras as bugs which can be activated by a special software (in which case the sneaks' eavesdropping is not live as happens with traditional microphones) and the use of battery powered environment bugs with built-in recorder to be placed in houses and neighbourhoods.

It is useful to bear in mind that old and new control technologies don't need sophisticated methods or expensive equipment to be discovered. Quite often the technicians who install them leave traces of their dirty visits, for example broken locks, displaced furniture and objects, oddities in the internet connection, background noises in the telephone, shadowy individuals outside the house, strange customers at the workplace, diligent escorts accompanying your trips out, etc. It is up to our intelligence and love for life to find the way of mocking them and prevent them from making our lives heavier.

Lecce: Update on repression and anti-militarist protests (Italy)

On April 19 2013 the appeal sentence was pronounced at the court of Lecce, where some anarchists from Salento [Lecce] stood on trial. In 2010 the comrades had been sentenced to one year imprisonment for resistance against public official. They had been pressed this charge because they had unfurled an anti-militarist banner during a public concert and had defended it from the DIGOS' attempt at snatching it. The appeal trial concluded with the acquittal of all the defendants.

On April 11 2013 a group of antimilitarists staged a protest in piazza Saint Oronzo in Lecce, where various associations were demonstrating in favour of two Italian soldiers, Girone and Latorre. The comrades unfurled a banner, distributed leaflets and made speeches through a megaphone. On the occasion, the events that led to the 2010 trial were also mentioned.

On the previous day the comrades also intervened during the European Film Festival, and in particular during the talk entitled 'Relations between Puglia and Israel', which hosted the representative for culture of the Israeli embassy in Italy. Through a megaphone, a banner and leaflets, the comrades expressed solidarity with the Palestinians oppressed by Israel (it seems that no documentaries shown during the film festival took any account of the existence of Palestinians). The comrades also reminded the audience that in the village of Gagliano del Capo (Lecce) a made in Israel antimigrants radar antenna is about to be installed (the antenna has been tested by Israel in the Palestinians' occupied territories and subsequently exported to the rest of the world). In Puglia it is supposed to intercept small and big boats of 'illegal migrants'.

An enemy of militarism

Three letters of advice for saboteurs from Marco Camenisch

Greetings and advice from Marco Camenish to the *compañerxs* of chile in relation to Mauri's death.

Dear compañerxs,

I implore you to send these greetings and this simple but perhaps important advice to the *compas* of Chile and everywhere else. Allow me to express the latter because I have experience, because even the most experienced guerrillas "weren't thinking about this, the trivial and banal means that allow one to save their skin during the dangerous art of handling "explosive powders!

So on my part as well, from inside of Swiss prison, I send a strong embrace of solidarity to our compañeras and compañeros from Chile! Honor to compañero Mauricio!!! What goes for our warriors who have fallen during combat goes for those of us kidnapped by the enemy as well: those of us who continue fighting, the utmost solidarity we keep in life, because our community is fighting. What is useless (except for the enemy) and tragic for the struggle is solely those who, when a compañerx dies fighting or falls prisoner in the hands of the enemy, points with a hypocritical finger, murmuring of "useless death, useless imprisonment, of "tragedy, etc.

As a veteran combatant, it is with pain, but with humility as well, that I reflect on the possible causes of such an accident. Could it have been a short circuit (perhaps activated by a timer) of an electric detonator with a spark submerged directly into the black powder? Then there is a simple trick to avoid deaths, injury, and imprisonment. Well constructed, it does not impede the success nor the timing (in the place, in the delay) of the operation. A slow burning fuse (or more than one, parallel, they are easy to make) should always be inserted between the electric detonator with the spark on one side and the charge on the other, a fuse which in the case of an early or accidental ignition, can be seen or heard during the transportation and handling for activation; the same fuse has to be long enough to count seconds or perhaps centimeters necessary to place oneself in safety and possibly, to extract or cut, disconnecting the charge and therefore guaranteeing the safety of eventual passer-bys- and obviously even more secure would be to

insert/introduce with only one movement the fuse/fuses to the charge only in the place of attack and later activate the timer for the electrical circuit.

Urgent advisory from a veteran saboteur to the anonymous saboteurs of the August 2008 post in Farellones, Chile.

In relation to the sabotage in Chile, Aug. 12, 2008* (which according to the press involved an electric detonator), a veteran saboteur is obliged to offer this valuable assessment to every saboteur of towers, antennas, and other similar instruments.

Urgent advisory from a veteran saboteur to the anonymous saboteurs of the August 2008 post in (Farellones) Chile and in general to all individuals actively engaged in sabotage around the world!

Electric filaments and/or devices and/or detonators and/or connections and other elements on single or separate charges should not be used for posts, transformers, and other electric installations surrounded by an electro-magnetic field, only mechanical or chemical filament should be used and/or, if necessary a modern filament for two or more charges attached to the same structure, or a connection with blasting caps should utilize a chemical or mechanical detonator/filament as well

All of this is necessary because the electro-magnetic field which surrounds the electric conductors/ installations can easily charge through induction each electric element and set off an uncontrollable explosion during the application/preparation of the device with tragic consequences easy to imagine, as happened for example to Feltrinelli in Italy or in one case in Austria when an electric prong was applied to a high-tension power pylon resulting in an uncontrolled and premature

explosion and a grave mortal accident. By the same error of "apprentice" I had, also according to the experts of the acts in my penal summary/folder, a great deal of luck when I sabotaged a transformer and other targets on the perimeter of an electric substation utilizing electronic detonators and electric wire to connect the separate charges as well as a commercial electronic device to detonate the charges.

On derailments and stupidities... Letter from a veteran saboteur about the case of Adrián in México

This is a continuation of a valuable technical assessment written by a veteran saboteur. In relation to the Adrian's detention* an analyst wrote: "To derail a train, a terrible idea. The most prevalent account of the derailment was provided by the police. This version facilitated by the police and accepted by journalists and analysts has little credibility and collapses in light of the input by this veteran saboteur. Now, two possibilities remain standing: an unsuspecting transportation of the artifact on the train or an action that failed in its intent.

It is obvious how purely propagandist and defamatory the disinformation surrounding Adrián's case is, as well as the fact that some canisters of butane gas did not even tickle a train or some tracks.

In order to even put a wrinkle in a railroad track (possibly capable of causing a derailment) at least a few hundred grams of high power explosive is needed (in which the accompaniment of gas makes no technical sense) and if we say (the calculation will be an underestimation) the cut side of a track is 50 sq. cm, in order to shear it, the calculation is easy (25 grams of military grade explosive per square cm), and would take around 1.25 kilograms of high power explosive.

Later, if we take in to account, that for example commercial dynamite is weaker and that with black powder (which should be carefully placed behind a container of stable material, such as a thick plate, since inside of a simple "bottle" a flare up or shaking would not do a thing to a

8mm rod) the amount has to be multiplied six times in order to achieve the same effect and level of destruction, this would take at least 6 to 7 kilos of black powder, well the distortion of the "facts" of the "article" is clear from here. The hypotheses is that that was used against the tracks (implicit in the case of the jokes about the "derailment"), it would not deter traffic for even a moment. If the "news" of the "smoke in the train" was true we would still be facing an explosion of clumsy and precocious fabrication.

Furthermore, it is not casually that one of the "rules" of the urban guerrilla is to avoid as much as possible the transportation of artifacts and/or explosives aboard mass public transit due to the potential grave danger to those "unaware of the facts", danger which is already sufficiently great with all other methods of transportation in a populated environment...

- -Nicola Gai, Alfredo Cospito, combative anarchist prisoners held in Ferrara, Italy, for the attack carried out in 2012 against the executive director of Ansaldo Nucleare.
- -Jaime Gimenes Arbe, an anarchist prisoner of direct action of Basque origin, held captive since 2007 in prison in Monsanto,

Portugal and perversely mistreated in a regime of punishment who has been on hunger strike since April 1st.

- -Every imprisoned individuality in the whole world who fights against power.

Extracted Interview with Alfredo Bonanno: "No political position of compromise had to be accepted"

This extract is from an interview carried out by a correspondent of **Columna Negra** after a gathering held in the city of Monza, Italy on the 24th-25th of November 2012. The gathering discussed topics such as the situation of the Mapuche in Chile, repression in Europe, etc.

CN: Considering the scenarios of crisis at the global scale, characterized by the massive de-legitimization of the traditional political models, the economic and social destabilization people are now living under in Greece and Spain, etc, how can we understand the emergence of insurrectionary practices that you laid out from the end of the 70's to the middle of the 90's, considering the differences between the current moment and the context in which these ideas were developed?

AMB: It is true that there are considerable difficulties for international capital in its attempt to restructure its own repressive and productive structure. This situation, which has been led up to for some years, comes from the so-called "crisis" but does not refer to crisis in the sense of radical contradiction which announces the passage of a situation which can evolve to become intolerable for the future of capitalist management. There is nothing in these periodic sicknesses of domination which can lead in a determinant manner to a possible irrecoverable-and therefore revolutionary-situation. For these events to begin to have some elements of a revolutionary sense (severe difficulties in recuperation and control by international capital) necessitates our active participation, and it is here where true and real insurrectionary intervention is essential.

The experiences had during the 70's, up until at the least the end of the 90's, demonstrate that projects of an insurrectionary nature such as attacks against those responsible for and structures of capital, sabotage of production, abstention from politics and production, expropriation, re-appropriation of one's own time, etc - can contribute to fertile terrain in which we can advance toward the real and true insurrection, whether it be the materialization of a series of attacks of amplified dimension that can have as a result visible transformation (politically recuperated in the form of modified processes in the structure of domination), or less visible but stronger and more effective transformations, that is to say

practical projects that contribute to formulations of what we have called "the insurrectional project."

CN: According to various analyses, the current crisis appears to be an expression of generalized catastrophe which is made visible, amongst other things, in the open abandonment of many the democratic mask by many states as well as in the open militarization of repression. In light of this, in what manner can the practices of insurrectionary anarchism contribute to a resistance and generalization of the conditions of rupture which allow for the scenario of a budding manifestation of Social War on the part of the exploited?

AMB: Not any one general catastrophe, at least in my opinion. It is a matter of difficulties, capital is experimenting on a repressive and productive level, including a few speculative financial processes which have been established and which have been shown to be completely incapable of quaranteeing better security and better profits. The underlying structure of economic production remains relatively outside of the disasters provoked by speculation, and capital has taken cover, proceeding to reduce waste, reduce production costs, get rid of a few less promising productive social sectors and intends to do so successively. For this it has had to forcibly obtain a greater repressive policing capacity, greater and more efficient methods of control, and in a nutshell, to the extent of militarily preparing itself for a possible transition phase of Civil

What the current repressive and productive project is trying to definitively achieve is simply a restructuring at all levels to guarantee profits based on large foreign investors and undisturbed exploitation, which has always been the goal of these projects. It is our task to intervene in the clash with the utmost determination, to seek to combat this process. The means we have at our disposal are the insurrectionary ones. Attack, the organizational autonomy of the minimal base structures, the informality of these organizational structures, the destruction of the enemy, and generalized self-organization.

CN: Another relevant factor that has emerged during the recent past is the empowerment of the citizen which has reinforced leftist positions which are mostly motivated by the increasing precarity of their lives, as a defense against large corporations helping to restrain the spread of antagonistic dynamics. In light of this, on one hand, what are the possibilities that can open up from anarchist practices to curb this civil impetus? And, on the other, how do you believe that we can from the antagonistic trench, break out of the corner we have been put in by citizen-ism, and manage to go beyond locating ourselves "to the left of the left"?

AMB: Any disguised form of change, as citizenism can be, sooner or later shows its true colors and is unmasked by the facts. It is due to indirect collaborations with power by those who fear the worst that is adapts to obtain a simple lengthening of the chain. Grand analyses are not needed to indicate what must be done against capital's brown-nosers. In place of this we need to commit ourselves to the attack possible with our forces, without seeking possible compromises with political forces that do not belong to us and that today constitute capital's last offensive line, the one that is perhaps the most effective in recuperation. The insurrectional project - identifiable in informal base organization and the destructive assault against every project of repression - undoubtedly needs some ideas, more detailed information and knowledge that differ in relation to the different geographical situations that present themselves, but it cannot move away from its directive principles: attack, autonomy, informality, self-management.

CN: Understanding that the crux of the anarchist critique is the problem-atizing of the State, what do you believe are the points of questioning and work around an anti-state critique that favors the present deployment of anarchist practices?

AMB: Anarchists are obviously anti-state. The anarchist critique is directed at the annihilation of the State, although the practice is not limited to waiting for the State to be in difficulty to go out to the street and fight concretely to give it the final shove.

Anarchists are almost always present in intermediate struggles, or perhaps focused on local problems that people have in geographically determined places. These struggles seek to reduce the repression that weighs against a small part of a place's population, but it has great importance for all the exploited in general if considered correctly focused from the point of view of the insurrectional method and project.

CN: The proposals of informal action arise as a search for more direct forms of attack. Nevertheless, even during the 90's with the "Marini Case" the State had carried out an identification of informal practices (whether through framing or infiltration), leading to the current trial against the FAI-FRI and the "Bombs Case" in Chile. In light of this, and according to your experience, what elements of the proposal and practices of informality should be revised?

AMB: The State has worked almost twenty years in a precise manner (up to a point) to focus on the informal base organizations and the insurrectional method. In fact, power does not have sufficient means to predict all the informal initiatives due to the enormous creative potential of the latter. When the attack is realized on the basis of informal organizational characteristics, or in a way that is dispersed around territory, free from any political contamination, directed to destroying small (and not therefore less significant) targets-in other words, when we avoid centralizing on a sole target, or a few well visible and qualified targets, [the action] cannot be easily stopped.

Attention must be placed on choosing these targets, not letting ourselves be seduced by the extremely visible ones (the continued attacks which the compañeros in Greece are carrying out against the country's Parliament come to mind) which are therefore more protected and in the end are of little importance. The study of targets corresponds to the knowledge of the territory and also the analysis of the relation that is occurring between local and international capital. Much of this knowledge is now easy to find (just think of what can be found on the Internet) but some others are more difficult and require truly profound study.

What is normal? I ask because obviously, from the reaction of those strangers I live amongst, I am not remotely 'normal'. Holding down some shit job, marrying and breeding, running to own your own house, consumerism, drinking beer and watching TV after a day at work: this is the good life, this is the normality that those who love Society check everyone else against. These citizens hate anybody who dares to shine brighter than that and will do everything in their power to destroy the light-bringers. Because it is the Unique ones whose light makes the ignorant aware that their own grovelling conformity is nothing but a shadow of life.

The overwhelming feature of Society is submission to the systematic violence of the rich, and the suppression of any individual or group of individuals who challenge their order. It's always been like this and it always will remain so. The struggle of the individual against Society and the State is an eternal fight against the loss of historical memory and human dignity. It's the struggle of the Unique against the existent.

I never forget that subversion is not just explosion and wildfire: it's the steady constant perversion of the dominant values and morals of those in control of my life. Like the crowds of people who deny my autonomy, my space and my liberty. Most people are little more than robots that willingly gave up their control over their life without a struggle. I will attack their Society and the State with my speech, written words and deeds.

My ideas will never perish, as they do not belong to me. They return in every generation, in the few Unique ones who I share my nature with, like the stars in the night sky which call forth life across the infinite wastes. For me, anarchy is the black void of nihilist chaos which appears as the source of all creation and destruction. It's not merely a method of economic and social reformism as preached by the civil anarchists like good Christians with the rest of the socialists.
